	Have you found a trusted legal and financial advisor to conduct your estate planning needs?
	Have you identified, located and listed all your assets and any liabilities?
	Have you found an executor or co-executors to act on your behalf? Have you also found an alternate executor or executors?
	Have you chosen any specific gifts or bequests for family members, charities or others?
	Have you chosen a specific beneficiary for your registered assets (e.g. RRSP, RRIF, pension or TFSA)? Some registered assets you leave to a spouse or, in certain situations, to a financially dependent child or grandchild may be transferred, deferring a significant tax liability.
	If you're referencing beneficiaries of registered plans or life insurance policies in your Will, are these beneficiary designations in your Will consistent with the beneficiary designations in the plans or policies?
	Are there any loans or debts owed to you by members of your family that you wish to forgive in the event of your passing?
	Are there any special circumstances that need to be considered in your Will (e.g. children from a previous marriage, a common-law spouse, a pending divorce or bankruptcy of a beneficiary)?
	Have you prepared a memorandum that outlines the distribution of your personal possessions?

Bequest Wording

Here are some sample statements for including a gift in your Will to Perley Health.

Giving a percentage of an estate:

"I give to Perley Health Foundation, 1750 Russell Road, Ottawa, Ontario, twenty percent (20%) of the rest, residue and remainder of my estate to be used for the general purposes of Perley Health."

Giving a specific asset, such as shares of a company:

"I give to Perley Health Foundation, 1750 Russell Road, Ottawa, Ontario, 500 shares of ABC Co. Inc, to be used for the general purposes of Perley Health."

Giving a specific amount:

"I give to Perley Health Foundation, 1750 Russell Road, Ottawa, Ontario, the sum of fifty thousand dollars (\$50,000) to be used for the general purposes of Perley Health."

Designating your gift for a specific purpose:

"I give to Perley Health Foundation, 1750 Russell Road, Ottawa, Ontario, the sum of \$XXXXX to be used for (detailed description)."

Example:

...for the Therapuetic Recreation and Creative Arts Program ...for the care of Veterans who call Perley Health home

For gifts contingent upon certain conditions:

"In the event my (eg. brother, sister, etc.) does not survive me, I give \$XXXXXX or XXX% of the residue of my estate to Perley Health Foundation to be used for the general purposes of Perley Health"

We suggest you add a "**Power to Vary**" clause to your statement. For example: "If at the time of my passing my gift is unable to be used for the purpose I've made clear I want it to be used for, Perley Health Foundation may at their discretion direct the gift to a similar purpose."
